Rich Hill Pump Station

Mr. Schmitt felt it would be beneficial to construct a large sluice gate before sewage enters the pump station and would

afford the Authority 8 to 10 hours to respond. Mr. Schmitt and Mr. Jenkins will respond to the requests of the agencies.
