Supplemental Meeting February 24, 2020

The Supplemental Meeting of the Deer Creek Drainage Basin Authority was held at 6:00 p.m. at the Authority office located at 945 Little Deer Creek Road, Russellton, Pennsylvania.

Call Meeting to Order and Roll Call

Flag Salute

Piper Sandler & Co.

Mr. Chris Shelby, Managing Director of Piper Sandler & Co., was present and remarked that the interest rates are very favorable for the Authority. Mr. Shelby commented on the effect that the coronavirus might have on the market. He also noted the Authority could refinance or pay its RUS loans. He directed the Board's attention to the new debt service figures. He also mentioned he has worked with Mr. Brown, the Authority's solicitor. He mentioned the fee for their work would not exceed \$7.00 per thousand.

Janney Montgomery Scott

Mr. Timothy Frenz and Chris Campbell was present representing Janney Montgomery Scott. He reviewed the decline in interest rates for the past 20 years. He also pointed out the refunding opportunity for the Authority. Mr. Frenz reviewed the interest rates. He said the Authority's fee would be contingent on its credit rating, the length of the term and size of transaction. The range of the fees would be \$6.00 and \$7.50 per bond.

Boenning & Scattergood

Mr. John McShane was present to represent Boenning & Scattergood. He directed the Board attention to the Bond Discount page. He felt the Authority would receive the best bond discount. Mr. Vancheri asked Mr. McShane what assistance he could offer the Authority. He replied his company would work with the Authority's manager, accountant and engineer. He also added the Authority would have to buy bond insurance.

The Board decided to make a decision at the March meeting when the Solicitor and Engineer would be present.
